Reproductive Services - Central Washington Hospital and Clinics

POLICY:

It is the policy of Confluence Health to provide a guideline for which reproductive services are provided at Confluence Health organizations of Central Washington Hospital and Clinics.

PROCEDURE:

- A. Confluence Health provides services for the care of patients who need Obstetrical and Gynecological care. All patients will receive care based upon their individual needs.
- B. Services provided include the following, but is not limited to:
 - 1. Routine and high-risk obstetrical care
 - 2. In-patient obstetrical care
 - 3. Vaginal birth
 - 4. Cesarean birth
 - 5. Preconception counseling
 - 6. Infertility therapy counseling and therapy
 - 7. Abdominal and vaginal surgery to treat gynecologic conditions
 - 8. Incontinence procedures
 - 9. Laparoscopic surgery
 - 10. Treatment of ectopic pregnancies surgical and medical
 - 11. General adult and adolescent gynecological care
 - 12. Natural and traditional menopausal care
- C. Contraception Counseling
 - 1. Contraception
 - 2. Emergency contraception
- D. Management of Premenstrual Syndrome (PMS) and Premenstrual Dysphoric Disorder (PMDD)
- E. Sexually Transmitted Disease (STD) screening and treatment

- F. Termination of pregnancy if deemed medically necessary
- G. As per State Statute, Confluence Health does not mandate that any provider or staff member participate in the termination of a pregnancy that is deemed medically necessary. Only those providers and staff who are willing to participate should do so.
